1. Introduction

Improving environmental quality in and around Mediterranean port areas—by mitigating and reducing sediment and water pollution—is a priority shared by many ports across the Mediterranean and other European sea basins.

With this in mind, the TREASURE consortium is committed to sharing its tested solutions and lessons learned with a wider community of experts and stakeholders, to encourage the replication and upscaling of effective approaches.

Building on the results and outputs identified, the next step focuses on transferring the acquired knowledge and promoting its adoption. Starting from the initial idea of disseminating TREASURE best practices across Euro-MED territories and neighboring countries, project partners have developed a Transferability and Engagement Plan. Its goal is two-fold:

1. To share practical, evidence-based tools and governance models that can help ports and coastal administrations improve water and sediment quality; and
2. To collect feedback and insights from stakeholders, enabling the adaptation and scaling-up of TREASURE solutions in different territorial contexts.

2. 1ST WORKSHOP “TREASURE Port Improvements in Environmental Quality: From Evidence to Tangible Results.”

This workshop will offer participants from local, regional and national public administrations, infrastructure and service providers, ports and shipping companies, enterprises, SMEs, business support organisations, NGOs, and research and academic institutions across the wider Euro-MED area the opportunity to:

- Discover **five innovative solutions** developed and tested within TREASURE to improve environmental performance in port areas;
- Understand **governance models** and decision-making tools that support sustainable management of coastal and port environments;
- Exchange experiences and **lessons learned** with peers facing similar environmental challenges;
- Contribute to shaping future **transfer and replication actions**, ensuring that TREASURE outcomes respond to real operational needs.

By combining technical presentations, case demonstrations, and an interactive discussion session, the event will foster collaboration among diverse actors and promote the wider adoption of effective, evidence-based solutions for cleaner and more resilient Mediterranean ports.
