Central European Initiative

The CEI is a regional forum for cooperation and consultation, which promotes collaboration in Central, Eastern and South-Eastern Europe at political, economic and cultural level.
Founded in 1989, the CEI currently counts 17 Member States: Albania, Belarus, Bosnia and Herzegovina, Bulgaria, Croatia, the Czech Republic, Hungary, Italy, Moldova, Montenegro, North Macedonia, Poland, Romania, Serbia, the Slovak Republic, Slovenia, and Ukraine.

Since its inception, the Initiative's main aim has focused on supporting transition countries in their integration process with the European Union (EU). To achieve this goal, the CEI seeks to make a sustainable impact on strengthening the capacities of its Member States remaining outside of the EU to consolidate their institutional and economic background, thus bringing them closer to the Union.

In 1992, Italy signed an Agreement with the European Bank for Reconstruction and Development (EBRD) on the establishment of a CEI Fund at the EBRD "to assist the Bank's countries of operations in Central, Eastern and South-eastern Europe in their economic and social transformation process". A Secretariat for CEI Projects (later renamed Office for the CEI Fund at the EBRD) was established to manage the Fund.

The Fund, towards which the Italian Government has solely made a total contribution of 47.5 million EUR, mainly provides grant-type assistance for Technical Cooperation (TC) projects. The Fund has so far provided 27.7 million EUR for TC projects. It has also contributed about 2.9 million EUR to the Know-how Exchange Programme (KEP), its second instrument.

Introduction

Thirty years ago, on 11 November 1989, two days after the fall of the Berlin Wall and with the European continent facing major geopolitical and economic changes, the first nucleus of the Central European Initiative (CEI) was established as one of the first experiments of regional cooperation across political boundaries. 2019 marks the thirtieth anniversary of common and successful work of CEI members, creating a lasting platform for effective regional cooperation. In this framework Italy - as a founding member of the Initiative and as its main financial contributor - is proud to be holding the CEI Presidency in 2019, and is looking forward to working with other Member States to further reinforce the Initiative's capabilities.

The CEI Fund at the European Bank of Reconstruction and Development (EBRD) - established by the Italian Government in 1992 with the aim of supporting economic transition and development in the CEI region, in close cooperation with the Bank - has since its inception played a specific role in boosting economic and social transformation processes in Central, Eastern and South-Eastern Europe. Solely funded by the Italian Government with a total contribution so far of 47.5 million EUR, the CEI Fund finances grant-type assistance through Technical Cooperation and Know-how Exchange projects. Through the years, over 170 Technical Cooperation assignments have allowed the CEI Fund to extend its fruitful presence in sectors such as agribusiness, business and finance, energy, institutional

development, municipal infrastructure and services, SME support, and transport. These Technical Cooperation (TC) assignments have mobilised - or are expected to mobilise in the coming years - an amount of approximately 6 billion EUR of international investments, of which about 3.8 billion EUR are committed by the EBRD. Likewise, over 100 projects cofinanced through the CEI Know-how Exchange Programme (KEP) in the last 15 years have allowed for a successful transfer of know-how and best practices in sectors such as sustainable agriculture, capacity building, enterprise development, sustainable energy, good governance.

This annual report comprehensively outlines the TC projects and KEP projects financed through the CEI Fund at the EBRD in 2018. It ever more proves the usefulness and effectiveness of this funding instrument that Italy intends to finance also in the future.

As a matter of fact, economic and social progress of the CEI area remains an essential aim for the common efforts of the EBRD, the CEI and Italy. The same can certainly be said for regional cooperation, stability and progress on the European Integration path for CEI members willing to approach the EU. We are convinced the CEI Fund at the EBRD - also thanks to the commendable work of its capable staff - will continue to play an important role in this framework.

CEI Fund at the EBRD

The Central European Initiative (CEI) was founded in Budapest on 11 November 1989. It is a regional intergovernmental forum committed to supporting European integration and sustainable development through cooperation between and among its Member States. While acting as a platform for political dialogue, the CEI has developed a strong operational, result-oriented approach to regional cooperation. It combines multilateral diplomacy and financing as both donor and recipient.

In 1992, the Italian Government established the CEI Fund at the EBRD. Through this Agreement, the Italian Government acknowledged the great opportunity the newly created development bank represented for the CEI and its objectives.

Donor governments and partners make a vital contribution to the Bank's work by providing funds that act as a catalyst for investments and support other activities in countries of operations. Therefore, the CEI Fund was created "to assist the Bank's countries of operation in Central and Eastern Europe in their economic and social transformation process".

Despite its bilateral nature, the Fund has financed projects and activities targeting the entire CEI region with a sole Italian contribution of 47.5 million EUR. The Fund has mainly financed grant-type Technical Cooperation (TC) projects in support of EBRD operations in a number of areas, including agribusiness, energy, finance and business, institutional development and capacity building, small and medium-sized enterprises (SMEs), municipal infrastructure and services, and transport. The CEI TC Programme reflects the Italian, the CEI and the EBRD country and sectorial priorities.

In addition to the Technical Cooperation Programme, the CEI Fund has been a source of financing for the Know-how Exchange Programme (KEP) - a grant facility supporting capacity building and best-practice transfer from institutions in EU CEI countries to benefit recipients in non-EU CEI Member States.

The European Bank for Reconstruction and Development (EBRD) was established and opened for business with its headquarters in London in 1991 to help build a new, post-Cold War era in Central and Eastern Europe. It has since then played a historic role and gained unique expertise in fostering change in the region – and beyond – investing more than 130 billion EUR in over 5,200 projects.

From 1998 to 2006 the CEI Fund at the EBRD - in cooperation with a number of partners across the CEI region - co-financed Cooperation Activities, i.e. projects of small scale and limited duration, such as conferences, seminars, workshops, or other types of short trainings. Between 1998 and 2006, the CEI Fund supported 113 activities of this kind throughout the CEI Member Countries, with over 1.6 million FLIR

The Office for the CEI Fund is the operational body, which ensures constant dialogue between the CEI, the Italian Ministry of Foreign Affairs and International Cooperation (MAECI), and the EBRD for all issues related to the administration of the Fund. Through this Office, whose staff members closely collaborate with the EBRD banking teams, the CEI has managed to build a unique comparative advantage vis-à-vis other funds within the Bank. This collaborative approach allows the Office for the CEI Fund to better choose projects, thereby ensuring high leverage ratios as well as greater effectiveness and efficiency.

For the TC Programme, the Office for the CEI Fund regularly screens projects in the EBRD pipeline and supports the MAECI in the selection process. The Office also manages the Know-how Exchange Programme through annual Calls for Proposals (see Chapter 3).

Technical Cooperation Programme

EBRD technical assistance is primarily intended to contribute to the preparation and implementation of the Bank's investment and non-investment operations, and to provide advisory services to private and public sector clients. Technical Cooperation (TC) projects can assist in implementing legal and regulatory frameworks, institutional reforms, as well as achieving the highest standards of corporate governance. In general, TC projects enable the EBRD to:

- Make thorough preparations for its investments and undertake them more effectively.
- Pursue investment opportunities in higher-risk environments by reducing credit risks.
- Increase the impact of its projects in the transition process by supporting structural and institutional changes.
- Sponsor legal and regulatory reforms, institutional building, company management and training.

TC projects constitute the largest part of the activity funded by the CEI Fund at the EBRD. CEI Technical Cooperation is traditionally offered in the form of grant-type assistance. Operations include support for feasibility and pre-feasibility studies, project implementation, management training, capacity building, and pre-loan audits. These activities target a number of priority areas, including agribusiness, business and finance, energy, institutional development, municipal infrastructure and services, SME support, and transport. The strategic focus of technical assistance has moved over time in the direction of the least-advanced CEI Member Countries, in order to help them reach EU standards.


Since its inception, the Italian Government - through the CEI Fund at the EBRD - has committed 27.7 million EUR towards 171 Technical Cooperation assignments (see Annex 5). These projects have been coherent with the framework and general objectives of the EBRD and other International Financial Institutions (IFIs) and have represented a fundamental means of development for the CEI countries of operations.

Investment links

Technical cooperation grants typically involve technical expertise to help design or implement an investment project. The CEI TC Programme aims at supporting the Bank's investments and loans, either at project preparation or implementation phase. The CEI has undertaken projects, which yield high co-financing ratios. Between 1993 and 2018, the CEI Fund dedicated 27.7 million EUR to technical assistance operations. These TC projects are expected to mobilise around 6 billion EUR of international investments¹. The EBRD alone is expected to contribute to those investments with approximately 3.8 billion EUR. A Total Investment Ratio (TIR) can be calculated to show how many euros the international community is expected to invest for each euro granted by the CEI Fund for TC projects. Between 1993 and 2018, the TIR is estimated to be 1:221. The EBRD's share, alone, is expected to reach approximately 136 EUR for each euro of the CEI Fund dedicated to TC projects: this represents the EBRD Investment Ratio (EIR).

¹ Out of this total amount, over 103 million EUR of investments are expected to be mobilised by TC assignments approved in 2018.

Geographic distribution

The distribution of TC projects by country and their cumulative committed value since 1993 demonstrate the CEI Fund's focus on regional projects. Around 40% of its resources (over 11 million EUR) have been committed to regional operations through 52 TC assignments. As to country allocations, the initial focus on Central European

countries (which have since then become EU members) has shifted towards the Western Balkans and the European Neighbourhood Policy (ENP) countries that are CEI Member States. The charts below illustrate the geographical distribution of TC projects by number of assignments and their value over the period 1993-2018.

Chart 2.2. Cumulative distribution of TC assignments by country, 1993-2018 (share of a total of 171 assignments)




Sectors covered

The sector allocation analysis indicates seven main areas of operations in which the CEI has funded TC projects: agribusiness, business and finance, energy, institutional development, municipal infrastructure and services, SME support, and transport. According to this categorisation,

transport is the sector that has benefitted from the TC funds the most, followed by SME support and energy. The charts below illustrate the sector distribution of TC projects by number of assignments and their value over the period 1993-2018.

Cumulative distribution of TC assignments by sector, 1993-2018 (share of a total of 171 assignments)





Chart 2.5. Cumulative distribution of TC assignments by sector, 1993-2018 (share of total committed grants of ϵ 27,704,467)

Green Economy Transition. Project Preparation and Implementation Framework

BACKGROUND

The EBRD launched the Green Economy Transition (GET) approach in 2015 to put investments that bring environmental benefits at the heart of its mandate. Preserving and improving the environment are central features of a modern, well-functioning market economy and, therefore, key goals of the transition process the EBRD has been set up to promote. Building on a decade of successful green investments, the GET approach seeks to increase the volume of green financing from an average of 24% of EBRD annual business investments in a 10-year period up to 2016, to 40% by 2020. Through the GET Project Preparation and Implementation Framework (hereinafter called "the Programme"), the Bank is able to help its clients identify and realise energy and resource efficiency, climate change adaptation and environmental protection opportunities in their own operations as well as provide targeted training and assist in better prioritising and implementing the associated investments.

OBJECTIVES

The overall objective of the Programme is to assist both the Bank and its clients in the preparation and implementation of the most appropriate investment programmes or projects that will strengthen energy security with the highest possible resource efficiency and reduced environmental impact. The Programme will mainly target the general industry, agribusiness, power, property and tourism, transport, natural resource and municipal sector projects. But it will be available to support any project in the public and corporate sectors that may potentially have GET components. The Programme aims at raising the priority of GET projects and ensuring that viable projects are incorporated into the client's long-term investment plan. Assignments conducted under the Programme will include but not be limited to:

- Working with the technical staff of the companies to identify energy and resource efficiency, climate change adaptation, environmental pollution mitigation, reduction and remediation and sustainable and renewable energy production investments.
- Assessing the feasibility of the potential investments and assisting the Bank in reviewing/developing bankable investment programmes.
- Providing Energy Performance Certification or Sustainability Certification for selected projects and in countries where certification schemes are introduced.
- Capacity building and training of clients' professional staff.
- Promoting and awareness raising of public activities (seminars, workshop, information campaigns, etc.)
- Supporting clients in preparing the procurement of the required services during the implementation stage.
- Supporting clients in strengthening their corporate governance by developing sustainability and common reporting standard reports.
- Supporting the Bank in assessing technical and economic potential of sustainable energy generation and resource optimisation solutions across different sectors.

Energy and resource audit activities are a cost-effective way of translating potential Energy Efficiency (EE) gains into specific investments. By providing the GET Programme, the Bank will be able to help its clients identify and realise energy and resource efficiency, climate change adaptation and environmental protection opportunities in their own operations. It will provide targeted training and assist in better prioritising and implementing the associated investments. The CEI has strongly supported the Bank's Energy Audit Frameworks since 2004 and to-date CEI-funded audits have resulted in 351 million EUR of EBRD green investments. The further financing of the Programme by the CEI Fund is expected to be linked to an additional 40 million EUR of EBRD investments.

Preparation of a Corporate Plan for the organisational strengthening of Public Enterprise for State Roads

BACKGROUND

In North Macedonia, the EBRD focuses – inter alia – on regional integration. The Bank works closely with the authorities, other international financial institutions and private sector investors to help improve transport networks, thereby facilitating greater cross-border trade and investment.

In this framework, the EBRD is considering extending a sovereign-guaranteed loan for 10 million EUR to the Macedonian Public Enterprise for State Roads (PESR). The operation will enable PESR to finance the construction works for the rehabilitation of a single two-lane carriageway road section, 13 km in length between Kriva Palanka and Deve Bair near the Bulgarian border. The project is part of the eastern section of Pan-European Corridor VIII and will support North Macedonia's economic development and regional integration through improved connectivity between North Macedonia's north-eastern regions and the rest of the country as well as between North Macedonia and the European Union.

OBJECTIVES

PESR is looking for a firm or group of experts to improve its financial management as well as environmental performance by supporting the identification and implementation of corporate, financial, operational management required to meet the related covenants included in the EBRD financing documents. The main objective of this assignment is to assist PESR in the preparation of a corporate development programme to increase its institutional capacity, assist with

the enhancement of financial management functions, assist with the development of a mid- and long-term business plan including planning road maintenance resulting in improved asset management, and to create an effective, sustainable company.

Specific cost reduction and/or revenue increase measures will be introduced to improve business planning, operating and cost management practices. A Corporate Plan (CP) will be developed to further improve outdated asset management and maintenance practices and provide recommendations for the reduction of costs and for strengthening the collection of revenues with the aim to achieve profitability. An additional aspect of the assignment is the transfer of knowledge and skills to the PESR staff resulting from collaborative work between the consultant (a firm or group of experts) and the PESR staff.

The consultant will be hired/selected by PESR to operate inside PERS for the following purposes:

- Corporate Development.
- Financial Performance Improvement.
- Operational Performance Improvement.
- · Implementation.
- · Capacity Building Programme.
- Medium-Term Corporate Development Plan and Strategic
 Rusiness Plan

The assignment is expected to have an overall duration of 18 months.

Investment Climate and Governance Expert for Bosnia and Herzegovina, Serbia and Montenegro

SECTOR OF OPERATIONS Capacity building / Policy dialogue

EXPECTED RELATED INVESTMENT The assignment aims at strengthening the investment climate

BACKGROUND

A successful transition to well-functioning markets requires effective and accountable institutions of economic governance, inclusiveness and robust economic structures. The EBRD launched the Investment Climate and Governance Initiative (ICGI) in 2014 to support reformminded governments and its corporate clients to increase transparency, good governance and healthy competition. The ICGI is designed to increase the impact of the Bank's policy reform dialogue initiatives on areas of economic governance that directly affect the private sector, and where the EBRD has advisory and technical assistance capacity, by taking a strategic approach to their development. The Initiative has been launched in the framework of one of the Bank's core strengths: supporting partnerships between the public and private sectors. To capitalise on the EBRD's deep knowledge of its countries of operations, and its long history of assessing the political impact of its operations, the ICGI is overseen by the Governance and Political Affairs (GPA) team within the EBRD's Economics, Policy and Governance department of the Policy and Partnerships Vice Presidency. The GPA team employs a combination of tailored country programmes and targeted interventions. In countries with a strong demand for EBRD engagement and evident political will to introduce reforms that can improve the investment climate and economic governance, the ICGI develops full country programmes with a set of interventions detailed in a Memorandum of Understanding signed by the EBRD and the recipient government. Eight ICGI country programmes are currently being implemented in the following countries: Albania, Bosnia and Herzegovina, Jordan, Kosovo², Moldova, Montenegro, Serbia and Ukraine.

OBJECTIVES

In order to develop and implement its investment climate and governance reform programme effectively, the EBRD requires a full-time Investment Climate and Governance Expert based in Belgrade and covering Serbia, Bosnia and Herzegovina and Montenegro.

Serbia

Since the signing of the Memorandum of Understanding, the GPA team has developed a large portfolio of ICGI projects in Serbia, amounting to more than 2 million EUR of donor funds currently under implementation. Moreover, there is a very robust pipeline of additional ICGI projects in Serbia which are at various stages of preparation, and for which additional donor funds are being sought. The Investment Climate and Governance Expert will play a crucial role in ensuring an effective delivery of the existing portfolio and pipeline of projects, as well as in seeking new and innovative policy interventions to strengthen Serbia's investment climate.

Bosnia and Herzegovina

The flagship product of the MoU will be the establishment of an Investment Council under the Council of Ministers - a platform for public-private dialogue in support of investment climate and economic governance reform. One of the Bank's priorities in the country will be the implementation of projects that reinforce and complement the work of the Investment Council to maximise its impact in the area of investment climate reform. These projects are at their design stage, and the Investment Climate and Governance Expert will play a crucial role in ensuring their effective design and implementation.

Montenegro

The MoU signed in February 2018 outlines four priority areas for EBRD support: (i) strengthening public-private dialogue to enhance economic reforms; (ii) strengthening the Government's capacity for implementing key reforms in top priority areas related to EU approximation; (iii) supporting the delivery of the Government's eProcurement and eServices platforms, including a Single Access Point for SMEs; and (iv) strengthening the capacity of the Competition Authority to implement competition policy and enforce anti-monopoly legislation. The Investment Climate and Governance Expert will support the design and implementation of these and other high-priority projects that have been identified in Montenegro.

CEI Support to Small Business Initiative: Expansion of Origination and Execution Capacity Programme for SME Direct Finance and Risk Sharing in Belarus - Phase 2

SECTOR OF OPERATIONS SME development EXPECTED RELATED INVESTMENT 18 million EUR

BACKGROUND

Access to finance remains a key impediment to SME growth in Belarus, in particular local currency financing and in general longer-term financing. SMEs are disproportionately constrained, and lending to SMEs accounts for only 23% of the total credit of banks. Bank financing continues to be the prevailing source of funding for SMEs in Belarus, but banks generally do not offer specific SME products or lending practices tailored to the needs of small businesses. The EBRD is building on its experience of SME direct finance and is stepping up its direct engagement through its two main lending instruments: the Direct Finance Framework (DFF) and the Risk Sharing Framework (RSF). Through DFF, the EBRD provides direct financing (debt, equity or quasiequity) to local SMEs under its own documentation. Through RSF, the EBRD finances local enterprises (majority of which are SMEs) together with a Partner Financial Institution (PFI) under the PFI's documentation. Under RSF, the EBRD shares a PFI's exposure to a local SME through either funded or unfunded risk participation.

In 2017, the CEI Fund at the EBRD provided resources for supporting the expansion of the EBRD's direct engagement with SMEs in Belarus via DFF and RSF (the "Programme"). The Programme's main goal was to facilitate access to finance and promote the sustainable growth of the SME sector, which remains a key source of employment in Belarus. Small deals with local SMEs can prove challenging, especially considering the material gap between accepted local business standards (e.g. on corporate governance, financial reporting, environmental protection) and the international standards that the EBRD wishes to promote. Therefore, small deals require extra resources including a

much closer involvement at an enterprise level to bridge the difference in transaction costs between the EBRD's high standards and the prevailing local standards, and to support post-investment activities. TC resources prove essential both at project preparation and execution phases. In view of the above, TC funds are required to launch and expand the SME financing activity of the EBRD in Belarus, guaranteeing adequate execution capacity on the ground.

OBJECTIVES

This assignment is for a three-year extension (Phase 2) of the original project approved in 2017, with the same main objective, i.e. to facilitate access to finance and promote the sustainable growth of the SME sector. The Programme's implementation started in the spring of 2018 and is proceeding well. The market response has been extremely positive, and there is an ample need for the continuation of the Programme beyond the initially envisaged two years. The majority of SMEs benefitting from this Programme are expected to introduce new technologies and/or processes that help improve working conditions, organisational and environmental standards, making them more competitive. Their increased competitiveness will generate a good demonstration effect, leading more small and mediumsized businesses to improve operations, hence providing an impact at a sector level.

The programme will last an additional 36 months, and focus on at least 5-6 direct and risk-sharing financing transactions with SMEs per year, whereby 2-3 transactions will be signed, generating a volume of up to 6 million EUR of financing to Belarussian SMEs each year, totalling up to 18 million EUR in three years.

Enhancing Public Procurement Professionalism Capacity Building Programme

EXPECTED RELATED INVESTMENT No immediate investment link

BACKGROUND

Procurement is an essential component of public sector economic governance as it links an increasing value for public money and public service delivery with the creation of an enabling environment for private sector–led growth. While efficient public procurement leading to well-functioning public infrastructure is a prerequisite for economic growth, poor governance of public procurement can turn public investments into major economic liabilities and result in additional costs and waste of public funds. Deficient regulation and low capacity of human resources managing procurement is extremely costly.

The more efficient the management of public procurement, the better a country can take advantage of its purchasing power to promote economic activities. An efficient and productive management of public procurement depends on the level of procurement professionalism within the government and its agencies.

OBJECTIVES

In order to support this professionalisation of the procurement discipline, the EBRD and Italy, through the CEI Fund at the EBRD, has since 2012 provided scholarships to procurement professionals from the EBRD and the CEI region. This enabled them to participate in a one-year Master's Programme at the University of Tor Vergata (TVU) in Rome and since 2017 in an Executive Master's at Belgrade University (UoB).

The EBRD has designed a Programme for a period of five years to cover, on a sustainable basis, both the Master's programme at TVU in Rome, as well as the Master's programme to be delivered at the Western Balkans Centre of Procurement at the UoB.

The TVU programme was extended to the UoB on the basis of the excellent results achieved in the editions of the last six years and the need to satisfy a still very large unattended demand for capacity building in procurement in the EBRD's countries of operations.

The CEI Fund resources will support scholarships for admitted and qualified students from non-EU CEI Member States to cover a large part of tuition costs and lodging. The remaining costs are borne by the students and/or their employers.

The Master's at TVU is a full time, postgraduate Master's Programme organised by the Department of Economy and Finance, together with the Departments of Law and Industrial Engineering of TVU in Rome. The interdisciplinary content of the Programme, for a new culture of public administration excellence, know-how and values is meant to attract public purchasers with relevant experience in procurement as well as young students interested in preparing for a career in public procurement. It runs on an annual basis, with classroom lectures followed by distance learning and a mandatory professional internship.

The Master's at the Western Balkans Centre of Procurement, hosted by the UoB will be delivered with intensive lectures and seminars taking place 4 days a month throughout 12 consecutive calendar months, combining work and education. After completing the modules, in order to graduate, students will be required to write and defend a full final dissertation. Upon successful completion of the programme, the students will receive a Master's Diploma jointly awarded by the TVU in Rome and the UoB.

BACKGROUND

The building sector is the largest energy consumer in the EBRD region (around 40% of the final energy consumption). It has been one of the key priority areas for the EBRD's climate actions since 2012. The Bank promotes investments in profitable energy efficiency measures in residential, commercial and public buildings.

In this framework, the Autonomous Province of Vojvodina (APV) is committed to increasing the level of energy efficiency and renewable energy and is looking into unlocking the potential for financing energy efficiency in the building sector. There is a strong interest from the municipalities in refurbishing the majority of the buildings as most of the building stock was constructed between 1950 and 1980 and remains in its original state. Improved thermal insulation, solar systems, LED lighting, buildings control, heat recovery and the like are some of the measures that should collectively lead to a projected average energy savings between 30-50%, based on the EBRD's experience in the region.

The EBRD intends to explore the energy efficiency potential in public buildings, across a number of localities in APV, where there are three regions (Backa, Banat and Srem) with 47 municipalities. The aim of the study is to create a comprehensive database of public buildings in all the municipalities, which would include building inventories for municipal, autonomous province and government buildings, analysis of energy consumption as well as recommendations for potential investors for a thermal rehabilitation of identified/selected buildings.

The first part would cover primary schools and pre-school institutions. This would encompass the analysis of 760 facilities (233 primary schools, 404 kindergartens and 123 mixed). The second part would include an analysis of regional government buildings and buildings owned by the APV. The third part would cover health care and social institutions, secondary schools, colleges/faculties and student accommodation buildings. A pilot study has already been conducted for kindergartens and schools in five smaller municipalities in Banat: Bela Crkva, Opovo, Irig, Senta and Bač.

OBJECTIVES

The key objectives of the assignment are as follows:

- Produce a detailed inventory of public buildings owned by the municipalities, autonomous province and state.
- Assess the current state of the public building sector in Vojvodina in relation to energy efficiency, taking into account the various categories and sizes of the buildings.
- Identify and map out the localities and assess the current state of the public buildings in APV in relation to energy efficiency.
- Develop an affordable and bankable strategic investment programme with a long-term perspective according to best applicable technology, availability and replicability.
- Finalise and recommend who could be the potential beneficiaries of such projects, so that they can be considered for potential funding and mobilisation of grants, as relevant.
- Provide an estimate of the total energy saving potential of the identified building stock, achievable through energy efficient refurbishment (based on at least two energy performance scenarios for refurbishment) and prioritise buildings and investments for all the scenarios.

BACKGROUND

In North Macedonia, significant transition gaps remain in the energy sector in terms of moving tariffs towards cost-recovery levels, strengthening the capacity of the regulator and developing renewable sources of energy. The EBRD's focus is to strengthen the capacity of the regulator and to develop renewable sources of energy through projects and policy dialogue in addition to promote further energy efficiency in the private and public sectors.

In the framework of the wind power development, the EBRD is considering providing financing to Elektrani na Makedonija AD (ELEM) for supporting the construction and operation of an up to 50 MW wind farm approximately 130 km south-east of Skopje, in the vicinity of the village of Miravci in the Gevgelija Municipality, in the south-eastern part of North Macedonia. The site is on the southern part of the gorge Demir Kapija, at an altitude between 390 m and 700 m, an area characterised by low vegetation and relatively rough terrain. Construction is envisioned in two phases: phase A for up to 14 MW is currently being discussed with the Bank; phase B for another up to 50 MW would follow in a few years. Individual turbines will be in range 3-4 MW, class of turbines II.

A new access road (approximately 4 km long) and a transmission line from the existing 110 kV transformer station at Valandovo (approximately 17 km long) will be built for the purposes of the project.

The initial energy yield estimated by ELEM on the basis of the available wind data is a nominal annual power generation of approximately 127 GWh, and an annual equivalent load factor of 2540 full-load working hours.

Two wind measurement campaigns took place 5 years ago, both with masts of 50m height, for 18 months and 36 months respectively. Raw wind data is available.

The Company owns and operates a 36 MW wind farm located on the opposite side of the gorge (Bogdanci wind farm).

OBJECTIVES

The main objective of the assignment is to review and confirm the robustness of the wind measurement data, if required, and support ELEM in the collection of additional data, produce a yield assessment report and a concept design of the plant along with basic technical specifications.

The assignment will take full account of the existing technical and environmental documentation and studies. ELEM will prepare these documents for the assignment, which will be made available for the first field trip to the site and ELEM's Headquarters.

All the major technical features of the investment project will be analysed and commented, focusing in particular, on the following main tasks:

- Initial wind resource assessment.
- Incremental wind measurement campaign and revised wind resource assessment.
- Basic project design and technical characteristics.

Technology Review and Market Potential in CEI region about Floating Solar PV (Green Economy Project Preparation and Implementation Framework)

PROJECT SUMMARY

The EBRD is actively engaged in facilitating the growth of renewable energy. Particularly, in recent years, it has promoted and financed a large number of solar photovoltaic (PV) plants. Besides mature ground-mounted applications, floating solar PV power plants (installed over natural or manmade water surfaces) are becoming increasingly popular as costs continue to fall and the interest in reducing land use is starting to grow.

The main objectives of the assignment were:

- To review the main technical solutions which are commercially available for floating PV plants, including prevailing technologies and layouts, main suppliers, current costs, and selected international reference cases.
- To analyse the main investment and operation cost components in current market conditions and as forecasted for the mid-term future.
- To review the current penetration and assess the investment potential in the CEI countries in comparison with other relevant neighbouring countries of operations of the EBRD, by developing relevant case studies at prefeasibility levels.

ACHIEVEMENTS

This assignment focused on the technology and market review of floating photovoltaic solar power plants. It proved very useful for the EBRD to better understand the evolution of the technology and the core equipment, their applications, costs, technical and economic features, regulatory and market opportunities and constraints.

It confirmed the ample opportunities for expanding solar energy utilisation in non-conventional locations that do not affect land utilisation. The study looked at, even if at an initial superficial level, investment opportunities in selected EBRD countries of operation and confirmed the relatively good viability for floating PV.

The Western Balkan region and Ukraine, in particular, show very promising locations in various lakes and artificial water reservoirs; regulations do not seem to prevent pursuing such installations. The EBRD has, therefore, started an initial engagement with the national counterparts and potential market players to assess the interest in pursuing these opportunities. The Bank is at a relatively advanced stage of discussion, in particular, with a state-owned utility in the Balkans. It is considering bringing the project to its internal project review committee for initial approvals.

Environmental Pressures in the South Adriatic Sea and Coastal Areas - Implications for Regional Economic Development (Green Economy Project Preparation and Implementation Framework)

PROJECT SUMMARY

Reducing the major environmental stress affecting the Mediterranean Sea and its coastal areas, while strengthening the local economy and promoting local economic development is becoming more and more important for sustainable growth in Europe as well as the CEI countries of operation.

The overall objective of this assignment was to identify opportunities for interventions that support the economic development in the target region, while improving the surrounding environmental conditions. With particular focus on economic sectors located in the Mediterranean coastal areas, the main objectives of the assignment were:

- To identify marine and coastal areas in the South Adriatic Sea (Albania, Bosnia and Herzegovina and Montenegro) with present critical environmental stress and examine the risks for the marine and coastal ecosystems.
- To analyse and propose economic development sectors (transport, tourism, energy, aquaculture, fisheries, etc.) that have a potential to attract private and public investments and show a potential to mitigate environmental pressures with these investments, while promoting local economy development.
- To develop selected case studies for specific economic sectors introducing technologies for pollution reduction, enhancement of water security and improved water management systems as well as climate resilience in coastal regions.

ACHIEVEMENTS

The assignment complemented the feasibility studies of a potential EBRD investment within the scope of the Mediterranean Sea Programme which is led by the United Nations Environment Programme / Mediterranean Action Plan (UNEP/MAP).

It also provided key inputs to the EBRD's project submission to seek grant co-financing from the Global Environment Facility (GEF).

The results from the CEI-funded study provided valuable baseline information for the hotspot analysis in the Western Balkan countries included in the project and for the baseline and project scenario in the proposal preparation process. The pollution hotspot review and analysis of environmental conditions enabled the EBRD to identify priority locations that could potentially be targeted by projects to be developed as part of the GEF-funded MedProgramme. The EBRD's submission of the full proposal to the GEF is envisaged in the first semester of 2019.

Know-how Exchange Programme

The CEI Know-how Exchange Programme (KEP) is an instrument dedicated to offering co-financing to projects and programmes, focused on the transfer of know-how and best practices from EU to non-EU CEI Member States. The KEP offers grants to institutions from EU countries willing to share their experience with their partners in the non-EU CEI countries.

The CEI Fund at the EBRD has been co-financing KEP projects since 2004. To date, 101 projects have been financed for a total CEI Fund contribution of about 2.9 million EUR with an overall project value amounting to 14 million EUR (see Annex 6). The success of the Programme, which has steadily increased since its inception, has encouraged other CEI Member States, besides Italy, to contribute financially to the KEP as well.

As shown in Chart 3.1, the projects supported by the CEI Fund at the EBRD have targeted all non-EU CEI Member States. The countries that have benefitted the most from direct KEP assistance, since its establishment, are CEI Western Balkan countries.

Chart 3.2 demonstrates that the countries with most knowhow providers were Italy and Poland, followed by Slovenia. Bulgaria, Croatia and Romania are the countries that have been involved both as recipient and provider countries, because of their entrance into the European Union.

Chart 3.3 illustrates a rather balanced distribution among all the areas of intervention: sustainable agriculture, capacity building, enterprise development, and sustainable energy.

KEP grants are assigned through annual Calls for Proposals.

Main Call requirements

Any co-financing grant awarded shall not exceed 50% of the total cost of a given project. The maximum grant amount allocated to a single project cannot exceed 40,000 EUR.

What kind of projects are expected?

The overall objective of the KEP is to contribute to the development of the CEI region, bolstering social cohesion and economic dynamism while strengthening cooperation between and among the CEI Member States. Therefore, a Project Proposal has to be in line with the CEI Plan of Action. The KEP is focused on areas of intervention where CEI-EU countries demonstrate strong-rooted experience, and where beneficiary states exhibit the strongest need for assistance. Project Proposals are required to address at least one of the KEP priority areas, namely: European Integration, Capacity Building and Market Economy, Infrastructure Planning and Development, Agriculture, Energy, and Environment.

Who can apply?

The Applicant shall be registered in a CEI Member State also member of the EU, namely: Bulgaria, Croatia, the Czech Republic, Hungary, Italy, Poland, Romania, the Slovak Republic, and Slovenia. The following types of applicants are eligible to apply: all public and private sector bodies (not individuals), international and non-governmental organisations operating in the public interest, e.g. national, regional and local authorities, education/research institutions, and environmental organisations. In case of applications from international organisations facilitating cooperation between the know-how providers and the beneficiary institutions in the CEI region, the CEI grant shall be transferred to and managed by this international body.

Who can benefit?

The beneficiary(ies) shall be public and private sector bodies (not individuals), international and non-governmental organisations operating in the public interest, e.g. national, regional and local authorities, education/research institutions, and environmental organisations, registered in a non-EU CEI Member State, namely: Albania, Belarus, Bosnia and Herzegovina, Moldova, Montenegro, North Macedonia, Serbia and Ukraine.

Selection process

The applications undergo an administrative and eligibility check on compatibility to the Call for Proposals requirements. The shortlisted ones are then evaluated according to a merit point system published within the text of the Call.

Chart 3.1. Distribution of KEP projects by number of assignments according to know-how recipient countries. The projects with regional spread are highlighted in light green.






Chart 3.3. Distribution of KEP projects by number of assignments according to area of intervention.





Chart 3.4. Total value of KEP projects (share of 14 million EUR).





Know-how Exchange Programme Projects approved in 2018

In 2018, the Office for the CEI Fund at the EBRD launched a Call for Proposals for the selection of new KEP projects. 34 project proposals were received for a total requested CEI contribution of over 1.3 million EUR and a total project cost of more than 2.5 million EUR. The project proposals were evaluated against a set of pre-defined selection criteria and projects with the highest scores were granted funding (within the available budget).

SUMMARY DESCRIPTION

The EU Multi-Regional Market Coupling (MRC), currently linking the majority of EU power markets, consists in allocating cross-border transmission capacity in the most efficient way. As a result, electricity flows from the lower price zone to the higher price zone, maximising the social welfare. This is regulated by EC Regulation 2015/1222, where the European Commission has set down detailed rules for organising a single-day-ahead market and a singleintraday market across Europe. Indeed, the EU has chosen market coupling as the target model for cross-border capacity allocation among Member States. The marketcoupling project between EU MRC and the Balkans via Italy is part of a wider project of electricity market integration, the so-called Day Ahead Market Integration (DAMI) Programme, promoted within the Western Balkans Process. EC Regulation 2015/1222 will become part of the acquis communautaire that the Contracting Parties of the Energy Community are bound to implement. However, for the time being, Regulation 2015/1222 has not yet been transposed into the legal framework of the Balkan Countries. The project of electricity market integration between the EU and the Balkans via Italy remains one of the major challenges within the SEE Region in 2019.

A fist capacity-building project was financed by the CEI Fund at the EBRD in 2018 and successfully implemented. This is the second phase of the same project aimed at assisting the three beneficiary institutions in the preparatory phase of market integration and to foster the transposition and implementation of the EU regulation. The following objectives are foreseen: the involved representatives of beneficiary institutions will be able to understand the main methodologies foreseen in the EU Regulation and assess the impact on their national jurisdictions and to convey to their top management a clear view on the regulatory measures and formal acts needed to carry out the integration process. Thereby, four capacity building workshops will be realised, one in each different country involved in the project. The agenda of each workshop will be based on two main sources of topics: terms and conditions or methodologies foreseen by CACM and FCA Regulations and procedures already in place in the operational activities of market coupling. By the end of the project, each beneficiary National Regulatory Authority is expected to be able to assess the proposals of market integration design, cooperation agreement and operation agreement; suggest amendments to the proposals, if needed, and approve them; understand how to implement and enforce Terms and Conditions or Methodologies foreseen by CACM and FCA Regulations and start the early implementation process of CACM and FCA Regulations in their jurisdictions.

SUMMARY DESCRIPTION

Agriculture is economically and politically important in the Western Balkan region, but affected by underused resources and production potentials, underdeveloped agro-food chains and land fragmentation. National and international policies have strived to achieve economically, environmentally and socially sustainable agriculture and rural development, yet budgetary expenditures for the agro-food sector and rural areas are low compared with EU levels and absorbance of pre-accession assistance for rural development (IPARD) which are far from satisfactory. Among the main reasons for low absorption of IPARD funding are the lack of human capacity; the lack of knowledge and proper training of the public institutions; and the lack of knowledge transfer to the targeted stakeholders and potential applicants.

Hence, the project aims at improving and increasing participation in IPARD calls and fund absorption in Western Balkan countries. In this context, specific project objectives are:

- Enhancing capacities of extension services in the beneficiary countries to support applicants in scouting of funding opportunities and proposal preparation by providing technical and methodological knowledge and know-how and disseminating best practice and flagship initiatives
- Promoting opportunities offered by IPARD funding among potential applicants and enhancing participation.
- Establishing a mutual support network among all stakeholders and expertise to be increasingly valorised and capitalised upon.

SUMMARY DESCRIPTION

A nationwide food consumption survey to collect individual data on dietary intakes was started in Serbia and other Balkan countries according to the EU-MENU programme

undertaken by the European Food Safety Authority (EFSA) for promoting the adoption of harmonised methodologies in regularly monitoring dietary intakes to assess dietary exposure in European countries.

The project aims at sharing the knowledge acquired in performing nationwide dietary surveys according to the EFSA's EU-MENU methodology, exchanging dietary assessment platforms, to enhance the information management (collecting, processing, sharing) to design and implement a system for a continuous training system of fieldworkers specialists in individual dietary surveys (IDS). In this context, the main aim is to connect platforms to manage dietary assessment tools to perform training courses and internships for practicing in dietary assessment. Sharing platforms will allow for monitoring population food consumption habits in a long-term perspective. Specialists in dietary assessment able to manage the tools will be skilled to perform surveys. Participants are expected to acquire/ refresh skills to carry out dietary surveys. Managing the underpinning database will be a crucial part of the course(s). Among these specialists the future trainers will also be identified. A suitable communication strategy will also be designed and implemented. Thereby, the project is focused on desk analysis of Italian and Balkan systems; planning training system; dissemination of the project results. The project will produce results in two perspectives: one is the capacity in conducting surveys through a community of trained fieldworkers; the second one is the quality of the data collection in the framework of surveys. The expected project impact is committed to building a continuous training system for professionals trained to perform individual dietary surveys to estimate eating habits in order to assess dietary quality, dietary adequacy (food security), dietary exposure (food safety), environmental impact and societal implications.

SUMMARY DESCRIPTION

As important governance deficits remain entrenched across the Western Balkans, the EU has clearly reinforced its commitment to the region. SUMMARY DESCRIPTION

Europe is affected by many types of natural hazards: floods, storms, heat waves, earthquakes, forest fires, landslides, etc. Natural disasters, each year, produce heavy casualities and economic loss. Therefore, investing in prevention and preparation is the best strategy based on a cost-benefit analysis and the Sendai Action Framework, as well as a drastic loss reduction. A multi-risk approach is, therefore, necessary, due to the interdependence and connections between the elements and the resources exposed in the current European territories.

Moldova has an obligation to harmonise environmental and water management within EU legislation and to develop River Basin Management Plans (RBMP) with large public participation. Moreover, the new national water law foresees the creation of river councils for small sub-basins and has to transpose the Floods European directive into Moldovan legislation, which has not been implemented. This project will help the Moldovan institutions to implement the Floods European directive and will enable them to learn about the Italian system of emergency management and civil protection, certainly among the most advanced in Europe.

The main objective of the project is: to promote best practices and new technologies in the prevention and protection from natural and environmental risks through a mirror exchange between the Italian experiences of civil protection and emergency management in Moldovan situations. The nature and environmental risks involved in the project are: floods, landslides, earthquakes, forest fires. Hence, the expected project results are: the provision of the Italian regulatory and organisational framework to improve the national framework for prevention, awareness and training on risk management of beneficiaries, within a framework of multi-risk approach with reference to the European legislation on the floods directive; a joint composition with the beneficiaries of 4 risk scenarios (floods, landslide, forest fire, seismic) on four local situations and the identification of qualifying elements necessary for the drafting of a local plan or a wide cross-border area of civil protection and management of emergencies with the identification of structural works where already planned; overview of the main critical issues from landslides, floods, seismicity and forest fires in the identified scenario areas; preliminary identification of suitable sites and instrumentation hypothesis for integrative instrumental monitoring, identifying areas and significant features (river, landslides, dams, village, forest); evaluation of the systems of the Civil Protection control centre at the respective agencies and suggestions for the improvement and implementation of management software (Early Warning System).

The main purpose of this KEP project was to support the EBRD in launching the Green Innovation Vouchers (GIVs) scheme to boost the innovation capacity of domestic enterprises in the field of green technologies and resource efficiency by linking them to local R&D service providers (R&DSPs). The resulting cooperation will enable participating enterprises to raise their environmental performance and competitiveness.

Green Innovation Vouchers are grants that help enterprises to cover 90 per cent of the eligible R&D service costs, up to 20,000 EUR for standard and 50,000 EUR for mega vouchers. The R&D service will enable SMEs to develop new products, services and processes, or innovate existing ones, in order to improve resource efficiency, thus supporting transition to the green economy. The scheme is funded by the Austrian DRIVE (Delivering Resource Efficiency InVEstments) Programme. Project partners, together with the EBRD's Energy Efficiency and Climate Change team, carried out the following activities:

- Organise and conduct the launching event/workshop held in Belgrade on 5 December 2017 at the Serbian Chamber of Commerce with about one hundred participants to deploy the innovation voucher scheme in Serbia.
- Design the website for the innovation voucher scheme, to ensure the necessary visibility of the initiative and prepare the key application forms (http://inovacionivauceri.ebrd.rs/)

After the first 3 calls and out of 108 applications received, the EBRD approved 29 projects for development and implementation of green technologies and improvement of resource efficiency in Serbia. The total value of the awarded vouchers is 435,000 EUR.

SUMMARY DESCRIPTION

Since 2007, Kotor has been part of the United Nations Educational, Scientific and Cultural Organisation World Heritage Protection Programme and in recent years, the area of the Kotor Bay, has seen a considerable increase in the influx of tourists. This has resulted in a dramatic increase in vessel traffic, especially cruise ships, in a particularly complex area. The complexity of the coastline, bathymetry and the ship traffic has also caused some accidents related to maritime traffic, with the release of hydrocarbons into the sea, although on a small scale. Such collisions have a strong impact on the environment and human health, determine the blockade of port activities and require high remediation costs, with a large impact on the Mediterranean area.

The main objective of this KEP project was to protect the threatened area of Kotor Bay and to improve cooperation between Italy and Montenegro by investing in the future of one of the most important, historical, cultural, touristic and strategic places in the Adriatic Sea. The study focused on the definition, modelling and simulation of critical issues in terms of possible diffusion of pollution in the bay from the hydrometric point of view. Virtual simulations were run considering the forces acting on the bay (wind, currents, buoyancy effect, etc.) to depict the flow dynamics in the bay. Analyses about time-space pollutants dispersion were carried out together with a critical analysis of the results. Seminars were organised to raise comprehension related to the bay hydrodynamics and awareness of the pollutant risk due to vessel traffic in the bay. The numerical code has been transferred to the University of Montenegro, Maritime Faculty, and personnel has been trained. A strong connection between the know-how provider and beneficiaries has been established, also through joint participation in sectoral events for presenting the project results. In addition, project partners are also preparing a project proposal related to air pollution for applying to EU funds.

SUMMARY DESCRIPTION

The rationale for using a PPP arrangement instead of conventional public procurement rests on the proposition that optimal risk sharing with a private partner delivers better "value for money" for the public sector and ultimately the end user. PPP arrangements are more complex than conventional public procurement. They require detailed project preparation and planning, proper management of the procurement phase to incentivise competition among bidders. They also require careful contract design to set service standards, allocate risks and reach an acceptable balance between commercial risks and returns. These features require skills in the public sector, which are not typically called for in conventional procurement. The objective of the project was to foster PPP market development in Albania, to encourage the development of common PPP practices. The objective of the workshop was to allow participants to gain a knowledge of PPPs in line with the European Union standards and best practices. A 3-day training course was organised by highly qualified Italian experts, providing guidelines and know-how to representatives/institutions for the realisation of PPPs. It was composed of 4 modules (project identification, detailed preparation, procurement, project implementation) with training given by keynote experts.

SUMMARY DESCRIPTION

Procurement is an essential element of economic governance as it links the increasing value for public money, public service delivery, and creates an enabling environment for private sector-led growth. The more efficient the management of public procurement is, the better a country can take advantage of its purchasing power to promote economic activity. An efficient and productive management

of public procurement depends on the level of procurement professionalism within the government.

Since 2012, the University of Rome "Tor Vergata, has developed, together with the EBRD, an International Master Programme in Procurement Management (IMPPM) specifically designed for procurement officials from the Bank's countries of operation. In recent years, the high number of applicants from the Western Balkans has highlighted the need to fulfil the high demand for training and knowledge on procurement policy from the region that cannot be adequately met due to restrictions on the number of participants in Tor Vergata.

In this framework, this project supported the designing and launching of a full-time advanced postgraduate Master's Programme to improve skills and upgrade the competence of early and mid-career procurement professionals from across the Western Balkans. The Programme enabled students to study and build the capacity needed to design and administer procurement solutions to resolve complex, strategic, managerial and organisational challenges in addition to contemporary issues on the job. Special emphasis was placed on professional capacity, ethics, transparency and accountability. The learning activities and training modules covered relevant topics for good procurement such as strategic tools for purchasing procedure, economic analysis of markets, international procurement law, contract complaints and disputes, quality management & green procurement, PPP, integrity & anticorruption in public procurement.

The Master's was delivered at the campus of the University of Belgrade in presence of intensive lectures and seminars taking place each month throughout 12 consecutive calendar months. 34 students from six countries (Bosnia and Herzegovina, Bulgaria, Croatia, Montenegro, North Macedonia, Serbia,) graduated. The Master's is now recognised in the region as a leading programme for this professional area.

SUMMARY DESCRIPTION

The EU Multi-Regional Market Coupling (MRC), currently linking the majority of EU power markets, consists in allocating cross-border transmission capacity in the most efficient way. As a result, electricity flows from the lower price zone to the higher price zone, maximising the social welfare. This is regulated by the EC Regulation 2015/1222, where the European Commission has set down detailed rules for organising a single-day-ahead market and a singleintraday market across Europe. Indeed, the EU has chosen market coupling as the target model for cross-border capacity allocation among Member States. The marketcoupling project between EU MRC and the Balkans via Italy is part of a wider project of electricity market integration, the so-called Day Ahead Market Integration (DAMI) Programme, promoted within the Western Balkans Process. EC Regulation 2015/1222 will become part of the acquis communautaire that the Contracting Parties of the Energy Community are bound to implement. However, for the time being, Regulation 2015/1222 has not yet been transposed in the legal framework of the Western Balkan countries.

The KEP project aimed at transferring, to the beneficiary Authorities, knowledge on the process of market integration and on operational functioning of an integrated electricity market. The final goal consisted in enabling beneficiary National Regulatory Authorities to properly assess the market integration design proposal that will be submitted by the Transmission System Operators and Power Exchanges of each involved country. Four capacity-building workshops were realised, one in each of the countries involved in the project (Rome, Tirana, Belgrade and Podgorica) and focused on terms and conditions, and methodologies implemented in the EU (with specific reference to EU Regulation 2015/1222) and procedures already in place in the operational activities of market coupling in the northern Italian borders. Currently, the CEI Fund at the EBRD is co-financing the second phase of this capacity-building project that has started in January 2019.



Future Outlook: 2019 Strategy

The Strategy for 2019 sets out the country and sector priorities for projects to be financed by the CEI Fund at the EBRD in 2019 through its two programmes - the Technical Cooperation (TC) Programme and the Know-how Exchange Programme (KEP) - with an overall allocation of around 1.5 million EUR.

Within the TC Programme, the Fund's mandate primarily aims at supporting the EBRD's operations and related technical assistance activities to generate greater impact in the CEI Member States where the Bank works, fostering competitive, well-governed, green, inclusive, resilient and integrated economies.

The CEI's vision remains strongly focused on the EU integration process, and is, therefore, well aligned with the goals of the EBRD in the region. The EBRD works closely with the EU to support small businesses, advocate economic reform, encourage trade integration (within and beyond the region), improve infrastructure and municipal services, and promote green energy and technological innovation. In order to achieve these common goals, the CEI Fund will continue to support the EBRD to boost investment, growth and policy dialogue in the region across the following sectors:

Green Economy Transition, Sustainable Infrastructures including Municipal and Environmental Infrastructure as well as Transport, Agribusiness, Support to SME development, Improving the Investment Climate.

Projects with a regional impact will remain a priority, in line with the CEI's regional approach, while the project selection will also aim at ensuring an equal distribution of interventions among the countries of operations.

The CEI Fund's resources will continue to act as a catalyst for the EBRD's investments and activities. Priority will be given to technical cooperation projects where relatively limited grants mobilise significant investment opportunities.

The CEI Fund will also continue supporting its KEP, an instrument that offers small amounts of co-financing for projects focused on the transfer of know-how and best practices for public and private institutions from EU to non-EU CEI Member States. In this framework, KEP capacity building projects will mainly focus on:

European integration, Strengthening capacities of public administrations at all levels, Strengthening capacities of private sector recipients in areas having an impact on regional and local development, Assistance in economic and social transformation.

Through the TC Programme and the Know How Exchange Programme, in 2019 the CEI Fund will help the CEI countries achieve their transition and integration objectives by ensuring leverage and effectiveness in the use of Italian resources.
